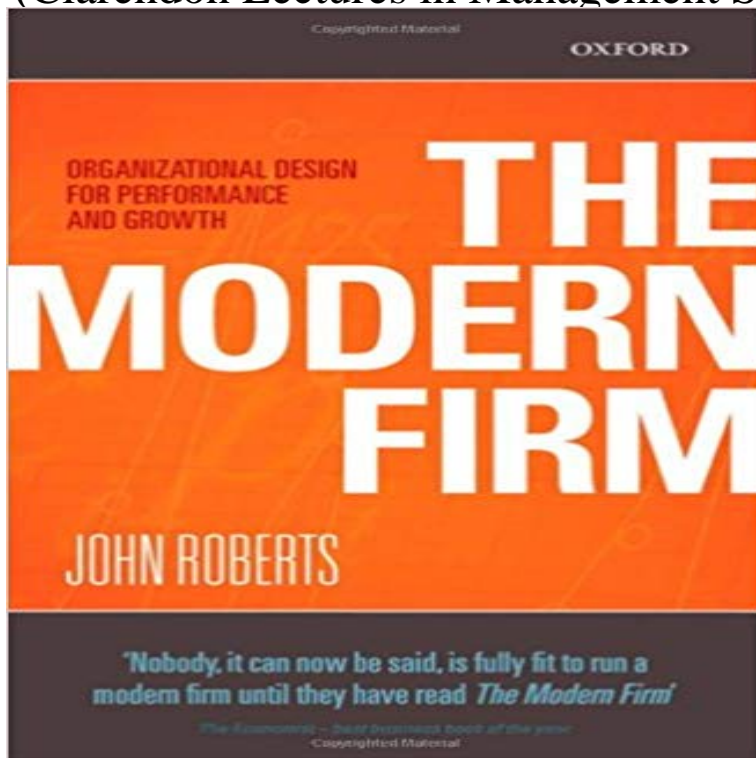


# The Modern Firm: Organizational Design for Performance and Growth (Clarendon Lectures in Management Studies)

Written in a non-technical language, the book is nevertheless based on rigorous modeling and draws on numerous examples from eighteenth century fur trading companies to such modern firms such as BP and Nokia. Finally the book explores why these developments are happening now, pointing to the increase in global competition and changes in technology.
